

TERMS AND CONDITIONS

J-TECH MEETUP BY J-LABS: The Digital Balance: Integrating Sustainable AI, Low-Code Efficiency, and Change Management Success Strategies

1. This terms and conditions (hereinafter referred to as the "Terms and conditions") defines the rules, scope, and conditions of participation, as well as the rights and obligations of participants and the organizer of the j-tech meetup by j-labs: Exploring cutting-edge technologies and their impact on the IT sector (hereinafter referred to as "Meetup").
2. The organizer of Meetup is: **j-labs spółka z ograniczoną odpowiedzialnością** with its registered office in Krakow, at ul. Zabłocie 43a, 30-701 Krakow, entered into the National Court Register (KRS) under number 0000366661, having Tax Identification Number (NIP): 6793048386 and Statistical Identification Number (REGON): 121351059 (hereinafter referred to as the "Organizer").
3. A participant of the Meetup can be an adult individual who has confirmed their participation in the event by completing the registration form (hereinafter referred to as the "Participant").
4. The Meetup will take place on the 16.04.2025, at 18:00, at the Smartvillage Bogenhausen - Rosenkavalierpl. 13, 81925 München.
5. Participants are required to adhere to the Terms and conditions, safety rules, occupational health and safety regulations, and fire safety regulations in force at the venue where the Meetup is organized. They should also comply with the instructions issued by the Organizer's staff in this regard and behave in a manner that does not endanger the safety of other individuals.
6. The data provided in the registration form, including: first name, last name, email address, company, are processed for the purpose of organizing the Meetup. You are vested with the right to demand access to your data, to rectify your data, to remove data or to limit the processing of data and the right to file an objection against the processing of data, as well as the right to file a complaint to the President of the Personal Data Protection Office (UODO).
